# **SOLICITOR**

Sol. Evashavik advised that Corrective Action Plan/Tap Allocation Plans expire on June 30; he will reach out to Bob regarding the CAP/TAPs to see if Chalfant is affected.

Mr. Hoover advised that Chalfant has received CDBG funding for the demolition of 120 Fairview. Sol. Evashavik detailed the condemnation hearing procedure and Council discussed scheduling the condemnation hearing for August 11th.

# **FINANCE AND ADMINISTRATION**

Mr. Hoover advised that the summer edition of the Newsletter will be coming soon.

#### PERMITS AND ORDINANCE

There were 83 violations on 21 properties in May:

Motion by Baburich, seconded by Syska, to transfer \$41,000.00 from the General Fund Money Market to the General Fund Checking. Motion was unanimous.

Mr. Hoover opened a hearing for Ordinance 433 which prohibits the feeding of deer and asked if there were any questions. Carol Donahue asked what the ordinance is? Mr. Hoover explained that it prohibits the feeding of deer in the borough. The ordinance requires bird feeders to be kept at least nine feet above ground and the area below the feeders must be kept clear. There were no other questions and the hearing was closed.

# **ROADS AND PUBLIC WORKS**

Mr. Syska advised that he submitted Chalfant's application to the Duquesne Light LED Street Light Conversion Program. Chalfant will be replacing 14 total street lights with LED lights on Elizabeth Ave., Wilkins Ave., and part of Brighton St. There were no questions from Council.

# **HEALTH AND SANITATION**

Ms. Fullwood advised that Chalfant has submitted six storm drains to Borough Engineer, Robert Zischkau, for rehabilitation.

#### **PUBLIC SAFETY**

Mr. Royster advised that there were two calls to the Chalfant VFC in May. He read a detailed narrative of each call and the number of members attending.

# PARKS AND RECREATION/BOROUGH PROPERTY

Mr. Royster read Mr. Lilac's report; he advised that the water is now on at the park and the Port-a-John has now been installed. Mr. Royster explained that the electrician has been notified about the light in the park that keeps going out and the issue will be addressed. The wall has been painted at the park and all lights at the Community Center and the Public Safety Building have been checked and are working.

#### WHEMS

Mr. Royster advised there were four calls to WHEMS in May. He read the date, location, and outcome of each incident.

Motion by Royster, seconded by Baburich, to transfer \$1,435.25, which is the amount of WHEMS tax collected in May, from the General Fund Money Market Account to the WHEMS Money Market. Motion was unanimous.

Ms. Fullwood asked if a child moves back into their parent's house, are they covered under the tax? Mr. Hoover advised that yes, they are, but they need to report the change in household to the borough secretary.

Ms. Baburich asked if the Car Cruise fundraiser for the VFC would be cancelled this year? Mr. Hoover advised that it hasn't been determined at this time.

Ms. Fullwood explained that the Greensburg Pike has been milled and is still awaiting paving; as a result, traffic is cutting through Chalfant to avoid it. Council then discussed the project and recommended calling Allegheny County to complain.
