## **FINANCE AND ADMINISTRATION**

Dr. Pustorino advised that the borough is currently utilizing the PA State Association of Boroughs' web design service. As Chalfant was one of the early adoptees of the service, the website needs to undergo some technology updates. In the next two months, Dr. Pustorino will be working with the PSAB's tech office to get the updates in place and deal with the back end content. Visitors to the website during this time will likely not see much disruption to the site, but the website will need to go offline for two days in February during the process.

## PARKS AND RECREATION/BOROUGH PROPERTY

Mr. Lilac advised that he will start looking into updating the cameras at Chalfant Servicemen's Memorial Park and will get quotes. A discussion regarding the number of cameras needed and the placement of the new cameras ensued; it was determined Mr. Lilac would likely need three or four new cameras and updated software. Mr. Lilac explained he also has some other projects in mind for the spring.

## **WHEMS**

Mr. Royster advised there were 11 calls to WHEMS in December. He read the date, location and outcome of each incident.

Motion by Royster, seconded by Lilac, to transfer \$122.75 from the General Fund MM Account to the WHEMS MM Account. This was the amount of WHEMS tax collected in December. Motion was unanimous.

Motion by Royster, seconded by Fullwood, to transfer \$11,482.98 from the WHEMS MM Account to the General Fund MM Account. This is the total amount of WHEMS tax collected in 2020.

#### **CITIZEN PARTICIPATION**

Dr. Pustorino advised that the Newsletter will be out soon and that the borough has scaled back on the number of Newsletter publications because rising costs have stretched the budget. Council and Ms. Donahue discussed the various social media platforms Chalfant uses to reach residents. Dr. Pustorino advised that she will post any tax information that Ms. Donahue needs to relay to residents on the webpage.

Motion by Baburich, seconded by Pustorino, to pass Ordinance 436. Motion was unanimous. Mr. Hoover closed the public hearing.

Motion by Lilac, seconded by Baburich to pass Resolution 560, amending Chalfant Borough Ordinance 436 to include all amendments and updates to the most recent edition or publication of the International Property Maintenance Code as the official building code of the Borough, effective 1/13/21.
